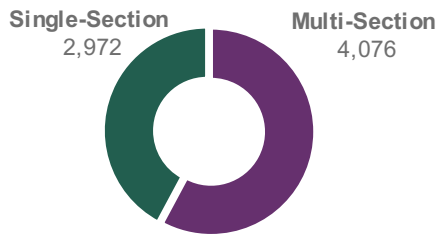

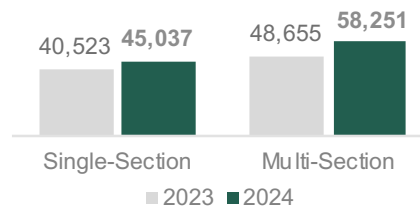

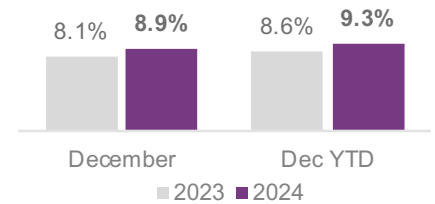

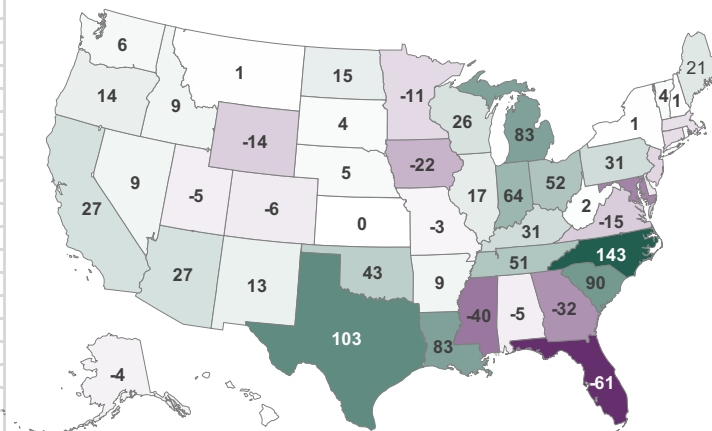

KEY FINDINGS

MANUFACTURED HOME PRODUCTION

- 7,078** Manufactured homes produced in December 2024. This month's production is 11.3% higher than a year ago (6,360 homes in December 2023), and 17.7% lower than last month (8,597 homes produced in November 2024). No FEMA units were produced this December, making the fiscal year total 169 homes.
- 103,314** Manufactured homes produced year-to-date. Through December 2024, production is 15.9% higher than a year ago (89,169 homes produced through December 2023 YTD).
- 152** Active homebuilding plants, operated by 38 corporations.

MANUFACTURED HOME SHIPMENTS

- 10.2%** Increase in monthly manufactured home shipments year-over-year (7,048 homes shipped in December 2024 compared to 6,394 homes in December 2023). Month-over-month, shipments decreased by 18% (8,600 homes in November 2024).
- 15.8%** Increase in total manufactured home shipments to date year-over-year (103,288 homes shipped through December 2024 YTD compared to 89,178 homes through December 2023 YTD).
- 103,571** Seasonally Adjusted Annual Rate of Shipments (SAAR) in December 2024. SAAR is 7.3% higher than a year ago (96,520 shipments) and 5.3% less than last month (109,313 shipments).

PRODUCT MIX & GEOGRAPHIC BREAKDOWN

- 42:58** Product mix of single-section (42.2%) and multi-section (57.8%) shipments in December 2024. Year-to-date, 45,037 single-section homes have shipped, a 11.1% increase from December 2023 YTD. To date, 58,251 multi-section homes have shipped, a 19.7% increase year-over-year.
- 64.4%** Market share of the top 3 geographic divisions for December 2024 shipments, including the East North Central (659 homes and 9.4% of total), West South Central (2,016 homes and 28.6% share), and South Atlantic (1,865 homes and 26.5% share).

CONTRIBUTION TO NEW SINGLE-FAMILY HOMES

- 9.3%** Manufactured home shipments as a percent of single-family home starts year-to-date, compared to 8.6% for December 2023 YTD. In December 2024 alone, shipments accounted for 8.9% of home starts (8.1% in December 2023).
- 13.1%** Manufactured home shipments as a percent of single-family home sales year-to-date, compared to 11.8% for December 2023 YTD. In December 2024 alone, shipments accounted for 11.9% of home sales (11.5% in December 2023).

Notes:

- MHI's Economic Reports include home production and shipments. The difference is attributed to changes in inventory.
- SAAR corrects for normal seasonal variations and projects annual shipments based on the current monthly total.
- Geographic Divisions above are defined as follows: East North Central is IL, IN, MI, OH, and WI; West South Central is AR, LA, OK, and TX; South Atlantic is DE, DC, FL, GA, MD, NC, SC, VA, and WV.

Chart E1. Monthly Shipment Comparison

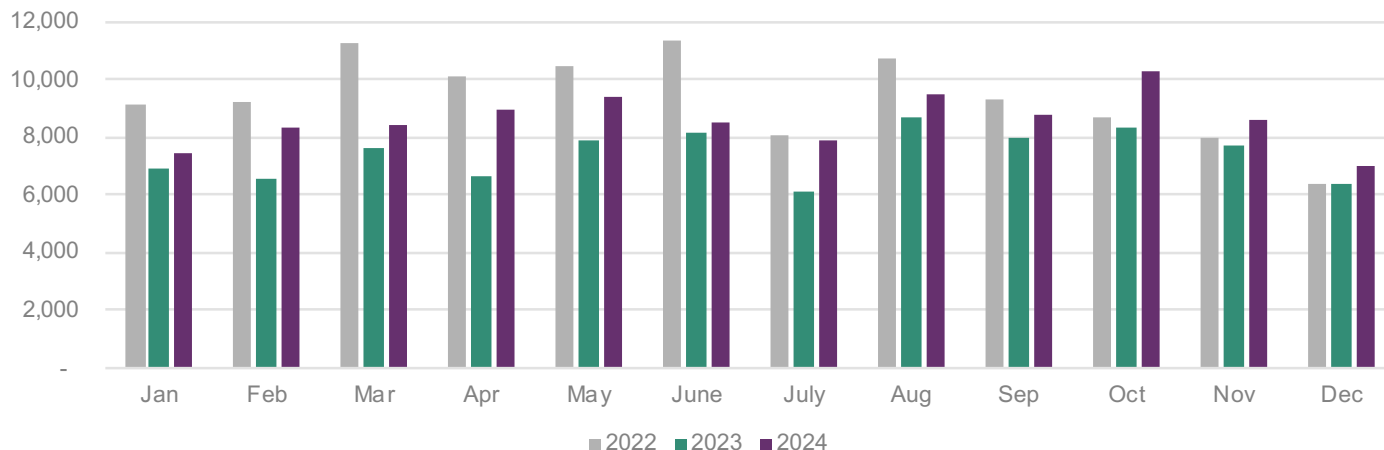

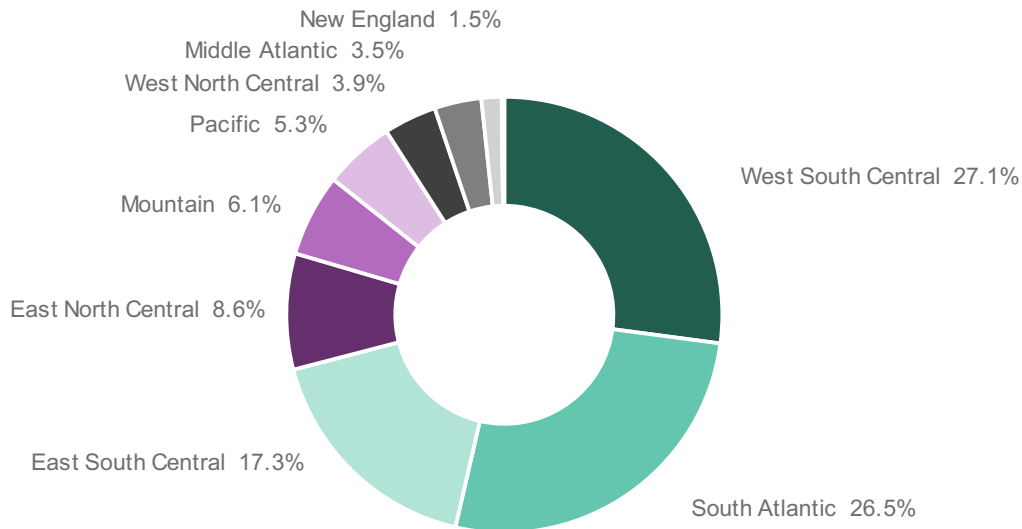

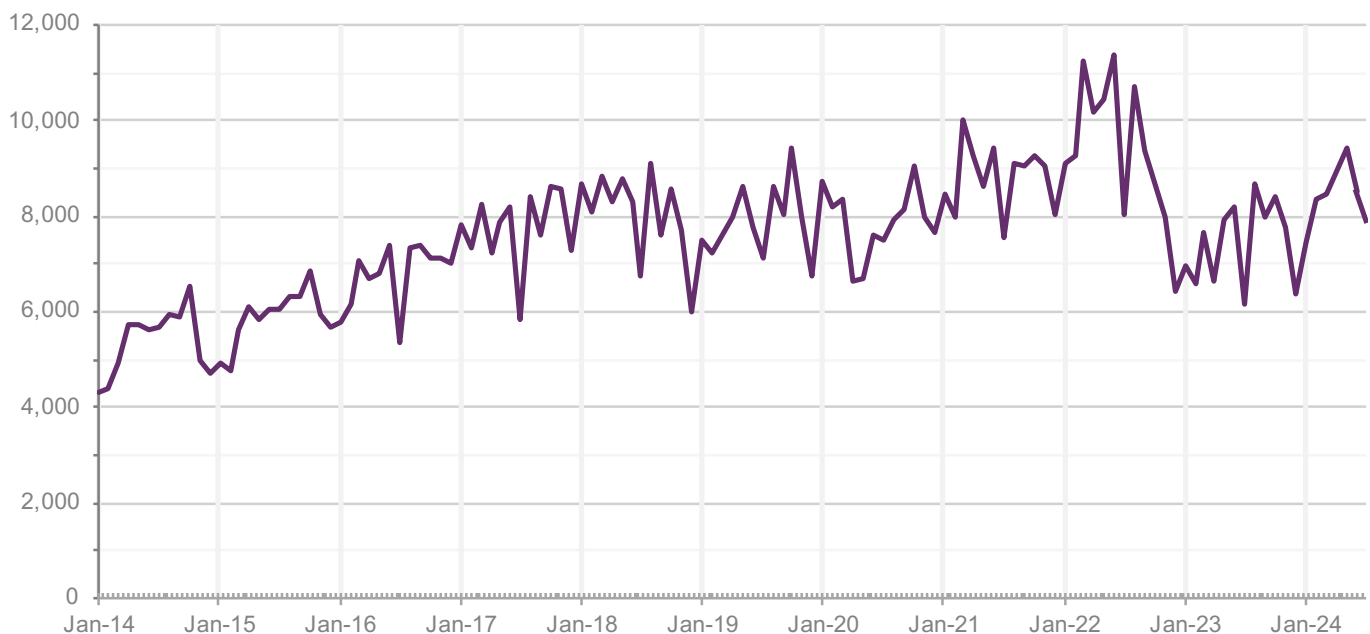
